Appendix I

A reflection of your teaching practices and philosophy of teaching or conceptual framework on what constitutes excellence in English Language Education KLA, General Studies or Personal, Social and Humanities Education KLA.

1. How do you conceive “effective teaching practice” with reference to English Language Education KLA, General Studies or Personal, Social and Humanities Education KLA? How does an effective teaching practice contribute to improving learning and teaching?

(You may briefly describe what constitutes effective/ exemplary/ innovative teaching practice and what criteria you would use to judge whether a teaching practice is effective or excellent.)

2. How do you formulate and implement your concept of effective teaching practice mentioned above?

(You may cite examples of education/ learning theories applied to your teaching practices, if any.)
